City Plan-What We Do

Serve as regulatory body for land use development

Engage the public to develop plans for long-term sustainable growth and development

Coordinate with departments and agencies to plan, secure funding and manage large infrastructure projects

Provide a first point of contact for residents, property owners, developers, entrepreneurs and business owners



New Haven Zoning Code

Updating the Zoning Ordinance and other regulatory updates to align with the Comprehensive Plan; examples include Affordable Housing- Inclusionary Zoning, Commercial Corridors, Green Ordinances, revising floor to area ratios to increase density and reduce parking requirements downtown and neighborhood overlays



Planning New Haven for 2025 - 2035

- Section 8-23 of the Connecticut General Statutes (CGS) requires each municipality adopt a Plan every 10 years
- Shall provide policies and goals for economic development, transportation, physical development, land use, neighborhood population density, growth management, housing development, housing diversity, elderly accommodations, and coastal management
- Projected 3-year process, divided into 4 phases



Plan Timeline

July 2022 -Mar 2023 • Definition Phase

- Establish steering committee structure
- Conduct initial outreach
- Conduct RFP/Q Process

March – Dec 2023 • Discovery Phase

- Meet with co-creation teams and steering committee
- Community engagement: forums, listening sessions, surveys, etc.

January – Sept 2024



Plan Mission Statement

The people of New Haven will use the Plan as a tool to create a promising shared future, focusing on the needs of the whole community and honoring voices and experiences, particularly of those who have been historically undervalued and excluded from facets of community life. The process of developing the Plan will be community-driven, representative, collaborative, and transparent. In the face of upcoming uncertainties, the Plan's concrete and actionable goals will serve as benchmarks for addressing systemic inequities and opening greater opportunities for all.



Discovery Phase Goal Statement

The Discovery Phase will build an archive of knowledge about New Haven from primary sources: the people who live and work here. The project team will meet the people of New Haven where they are to have frank conversations reconciling with the city's past and hearing visions of the future, with a special effort made to elevate historically underrepresented voices.

Discovery Phase Involvement Opportunities


March 2023 - December 2023
